"Cathy O'Neil earned a Ph.D. in math from Harvard, was postdoc at MIT in the math department, and a professor at Barnard College where she published a number of research papers in arithmetic algebraic geometry. She then chucked it and switched over to the private sector. She worked as a quant for the hedge fund D.E. Shaw (where she worked with Larry Summers) in the middle of the credit crisis, and then for RiskMetrics, a risk software company that assesses risk for the holdings of hedge funds and banks. "While attending college at the University of California-Berkeley in the early 1990s, O'Neil never considered herself political. After studying number theory at Harvard and completing a mathematics post-doc at MIT, she joined D.E. Shaw in 2007, where [she worked with Larry Summers and] her job was to use mathematical reasoning and statistical modeling to predict movements in the market. Three months into her job, the stock market dipped, a hedge fund failed, and her firm lost a ton of money. She started to question many of the assumptions underpinning her work."

Each year the Amherst College Black Student Union has attended this conference, in an effort to meet with other college Black Student Unions and Associations to discuss pertinent issues in the black community. The Black Solidarity Conference was founded in 1994 around the concept of Black Solidarity Day, an event inspired by Douglas Turner Ward's play Day of Absence. The conference serves as a forum for students of color to exchange ideas and opinions about pressing issues while providing an avenue to network with peers. In the past we have had speakers such as Dr. Na'im Akbar, Dr. Kathleen Cleaver, Aaron McGruder, Spike Lee, Cousin Jeff from Cousin Jeff Chronicles, Tavis Smiley, Dr. Michael Eric Dyson, and most recently, Dr. Cornel West.
