Requests

- Rep: requesting funding for U-Haul to move boats post-season Rep: will incorporate into formal budget moving forward, last year we had trailer but it's pretty broken so it's easier to use this U-Haul
- J: one use type of thing?
 - Rep: yeah
- Ioannis: trailer would be more difficult right
 - Rep: for this occasion it's better to have a covered U-Haul

- 3. La Causa requesting funding for event
 - Rep: for Voices event- another night's stay at Lord Jeff Inn for 7 poets, \$1120
 - J: why are they all staying an extra night
 - Rep: flying in Friday (because we have an event then, as well as Saturday, so they fly out Sunday morning)
 - Rep: invited them to Friday night but that's not necessary
 - Rep: Voices is a spoken word event that is an international thing, 20th annual
 - Rep: 200+ people
 - Rep: student night event on Friday will be open to any student, students perform probably at Lime Red

- J: why are we giving them an extra night, I guess if you already received funding for the flights and booked the tickets then you need the accommodations for the performers, but keep in mind not to book flights until you have accommodations in place for that time period, because this puts us in a tight position to have to fund accommodations
- J: we don't fund honorariums for time that the performers stay here without performing, so they're being paid a hefty amount they shouldn't be just watching performances

Discussion

1. Today's requests and funding events over break periods

- J explains the previous requests
- Jordan E brings up the over spring break rule
- Natalia: since we funded frisbee I feel like there's no precedent any more
- Sade: I think there is a precedent now so over break we should be able to fund things
- J: we did start funding the frisbee tournament before we set the rule not to fund things over break, so now that we funded it after zeroing it then we have a new precedent
- I: I think we can fund over break but make it harder to get funding, have harder criteria
- N: for reference, La Causa only asked for one night last year, should set that as precedent

 J: yes

- S: we should talk about this at some point
- N: clearly the ACF retreat thing, they were able to do it without funding so they should be able to get funding in the future, could be a rule we internally establish
