Event Details: This is for lesson subsidies. Our club is continuing to grow as people on campus become aware of it, which is great, but it does mean that we have more people taking riding lessons and therefore more people asking for AAS assistance in paying for lessons. This year, we strongly recommended that people pay even some small portion of the \$350 fee (many people were able to pay \$10-50, with many paying larger sums or even in full). Based on the BC's recommendation last semester that we limit funding for more than one lesson/week (\$350), there are only two students who are taking two lessons (\$700 and a recommendation for competing students) and are asking for subsidies for more than 50% of that. We want everyone to be able to ride and participate in this club, and we feel that excluding students based on financial status would violate the the BC's non-discrimination policy.

BC Comments: Diwa notes that lesson subsidies are only for the first lesson (until this year, when they were changed).

Jess wants to know if this needs to be a referendum.

Matt says it's ok with him.

Amani says she no longer agrees with the decision made previously.

Event Details: Line Items #1-3 all pertain to the Girl Scout Cookie Transgender Awareness Event we will be hosting on March 3rd. Recently a Girl Scout troop in Colorado admitted a 7-year-old transgender girl into its troop. In response, a group calling itself HonestGirlScouts.com has posted a YouTube video calling for a boycott of Girl Scout cookies. Pride Alliance is sponsoring a Five College transgender awareness event where Girl Scout cookies are served. We feel that it is important to educate the community about the importance of transgender inclusive policies and practices, and show support for the Girl Scouts of America's policy. The GS cookies are central to the event, as they are at the center of this controversy. Genny Beemyn, author of the book The Lives of Transgender People, will speak at the event, and we will show the YouTube video calling for the boycott and discuss. We are asking for funds for 50 boxes at \$4 per box, totaling \$200, as well as \$400 honorarium and \$12.50 publicity. We are asking our Five College counterparts to match this and bring their own cookies to the event.

Line Items #4-6 concern Gay Amherst Parties. The two GAPs this semester will occur on March 10th and April 14th. In our semesterly budget, only the first DJ (costing \$350) was approved, so we are now applying for the second DJ. We are also applying for security funding, which is required by the college as these are 5-college parties.

Line Item #7 is for We Were Here, a powerful documentary that takes a deep and reflective look back at the arrival and impact of AIDS in San Francisco. Though a San Francisco-based story, We Were Here extends beyond San Francisco and beyond AIDS itself. It speaks to our capacity as individuals to rise to the occasion, and to the incredible power of a community coming together with love, compassion, and determination. Amherst alumni attended screenings of this new documentary and wrote to Pride Alliance recommending it highly. We wrote to the distributor of the documentary and have been told that we can get an institutional copy of the film for \$295 plus \$15 shipping and handling. That would include a one-year classroom streaming license, so that faculty could show it in class for educational purposes if they wish.

Line Item #8 is for Rainbow Room resources, books and DVDs. The Rainbow Room houses a library of books, DVDs, and periodicals for student use. We request \$250 for the purchase of additional, updated items for the library. We will present final receipts, of course, listing the specific films and books purchased.

One other note: We have completed our elections for our Spring 2012 Executive Board positions. Our new treasurer is Timothy Yuan '15 (tyuan15@amherst.edu), and Pride-BC information should go to him as well as myself and Nora Gayer '14 (ngayer14@amherst.edu) who are continuing in advisory positions. Thanks!
